# Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

### You are about to purchase a product that is not simple and may be difficult to understand.

## What is this product?

This product is a structured investment. Your money will be used to buy securities issued by Investec Bank plc

### Objective

This product is denominated in USD and is designed to return your initial investment as well as delivering quarterly income payments linked to the performance of the FTSE 100, EURO STOXX 50, S&P 500 and Nikkei 225 (the "Underlyings") over the term of 6 years. This product also has the potential to mature early ("Kick Out"), returning your initial investment, depending on the performance of the Underlyings.

### **Income Payments**

At the end of each quarter, if the worst performing Underlying is above 80% of its starting level this product will pay you an income payment of 1.5%. If the worst performing Underlying is equal to or below 80% of its starting level, the income payment for that quarter will be missed. Instead the missed payment will be added to any subsequent payment.

#### **Early Maturity (Kick Out)**

This product will "Kick Out" at the end of any quarter from the 2nd year onwards, returning your initial investment plus an income payment of 1.5%, if the worst performing Underlying is above 100% of its starting level.

### **Maturity After 6 years**

If no Kick Out occurs and the product runs to the end of the recommended holding period, your return will be determined accordingly:

- If the worst performing Underlying is equal to or above 60% of its starting level the product will return your initial investment. If the worst performing Underlying is above 80% of its starting level, you will also receive a final income payment of 1.5%.
- However, if the worst performing Underlying is below 60% of its starting level, your investment will be reduced by 1% for every 1% fall in the worst performing Underlying.

### Intended Retail Investor

This product has been designed for investors who are looking to potentially achieve a high level of contingent income over a term of 6 years but can accommodate receiving their money back before the end of the term. Investors will have a medium-high appetite to risk. They will be prepared to risk their capital in order to achieve higher returns. Investors will understand that the potential returns of this product are linked to the performance of the FTSE 100, EURO STOXX 50, S&P 500 and the Nikkei 225. Additionally, investors will have knowledge and understanding of this structured product from supporting product literature and any advice they have received, as well as an understanding of financial markets.

# What are the risks and what can I get in return





The risk indicator assumes you keep the product until 02 Sep 2025. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 5 out of 7, representing a medium-high risk class. This classification rates the potential losses from market movements during the term of the product as medium-high. Poor market conditions will likely impact the capacity of Investec Bank plc to pay you.

Be aware of currency risk. You will receive payments in a different currency (USD), so the final return you will get depends on the exchange rate between the two currencies. The risk is not considered in the indicator shown above.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

## What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The table above shows the split of the reduction in yield shown in the costs over time table after a maturity of 2 years. The split of the actual estimated costs of the product as a percentage of the product notional amount is estimated to be as follows: entry costs: 9.65% and exit costs prior to the end of the recommended holding period: 0.5%.

# How long should I hold it and can I take money out early

### Recommended holding period: 6 years
