

Key Information Document

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type The product is in the form of a note issued under English law. It is an interest bearing security, but your interest is not guaranteed. The payment obligations of the product manufacturer are not guaranteed by any entity.

Objectives The product pays interest that is linked to the performance of the underlying assets (as defined below). What you will receive at the end of the term of the product is not certain and will depend on the performance of the equity securities of ASML Holding N.V. New York Registry Shares (ISIN: USN070592100), Equinix, Inc. (ISIN: US29444U7000), Honeywell International Inc. (ISIN: US4385161066) and Microsoft Corporation (ISIN: US5949181045), listed on NASDAQ Global Select Market (the **underlying assets**). In addition, you will take the risk that some or all of the value of your investment may be lost at the end of the term of the product. The term of the product will end no later than February 2, 2026. However, the product may terminate early depending on the performance of the underlying assets. Each note has a face value of USD 1,000. The issue price is 100.00% of the face value. The product is not listed on an exchange. The issue date is February 2, 2022.

Interest: If the closing price of each underlying asset on an interest observation date is at or above its interest barrier, you will receive interest of USD 26.35 on the corresponding interest payment date for each note that you hold. In this case, you will also receive USD 26.35 for each previous interest payment date where no interest has been payable. Interest observation dates are each trading day rolling quarterly from April 26, 2022 (inclusive) to January 26, 2026 (inclusive). Interest payment dates are dates falling 5 business days after each interest observation date.

Autocall feature: If the closing price of each underlying asset on any autocall observation date is at or above its autocall barrier, the product will terminate on the corresponding autocall payment date. In this case, you will receive USD 1,000.00 in addition to any interest payable on or around such date for each note that you hold. Autocall observation dates are each trading day rolling quarterly from July 26, 2022 (inclusive) to January 26, 2026 (inclusive). Autocall payment dates are dates falling 5 business days after each autocall observation date.

Repayment at maturity:

This section applies only if no autocall occurs as described above.

On February 2, 2026, for each note that you hold:

- If the closing price of the underlying asset with the lowest performance (as compared with its initial reference price) on January 26, 2026 is at least equal to its barrier price, you will receive USD 1,000.00; or
- Otherwise*, you will receive USD 1,000.00 multiplied by (i) the closing price of the underlying asset with the lowest performance (as compared with its initial reference price) on January 26, 2026 divided by (ii) the strike price of such underlying asset.

The strike prices, barrier prices and initial reference prices are shown below.

The initial reference price of an underlying asset is the closing price of such underlying asset on January 26, 2022.

The strike price of an underlying asset is 100.00% of the initial reference price of such underlying asset. The barrier price of an underlying asset is 70.00% of the initial reference price of such underlying asset.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the

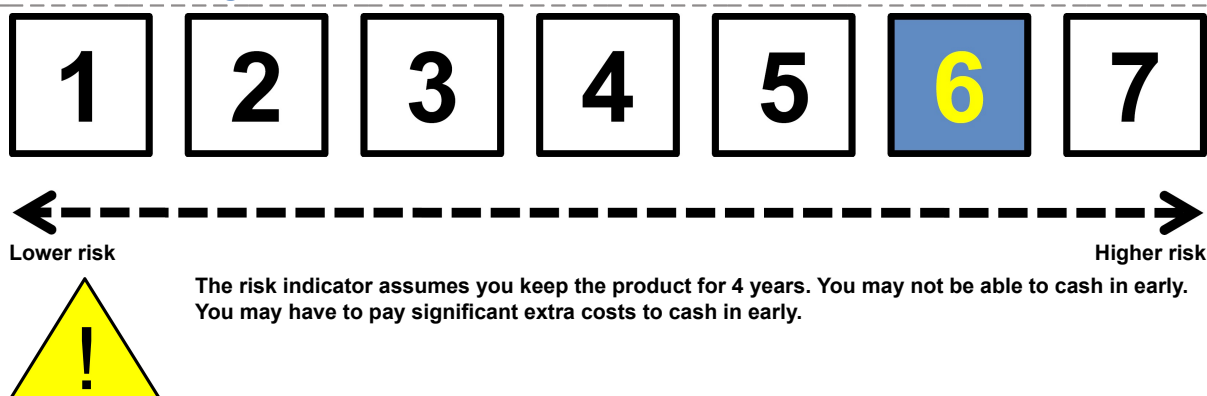
underlying assets, the product and the product manufacturer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

Intended retail investor The product is intended to be offered to retail investors who:

1. have the ability to make an informed investment decision through sufficient knowledge and understanding of the product and its specific risks and rewards, with experience of investing in and/or holding a number of similar products providing a similar market exposure;
2. seek income, expect the movement in the underlying assets to perform in a way that generates a favourable return, have an investment horizon of the recommended holding period specified below and understand that the product may terminate early;
3. accept the risk that the issuer could fail to pay or perform its obligations under the product but otherwise are able to bear a total loss of their investment;
4. are willing to accept a level of risk to achieve potential returns that is consistent with the summary risk indicator shown below; and
5. are making use of professional advice.

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 6 out of 7, which is the second-highest risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a high level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

Market developments in the future cannot be accurately predicted. The scenarios shown are only an indication of some of the possible outcomes based on recent returns. Actual returns could be lower. This table shows the money you could get back over the next 4 years under different scenarios, assuming that you invest USD 10,000.00. The scenarios shown illustrate how your investment could perform. You can compare them with the scenarios of other products. The scenarios presented are an estimate of future performance based on evidence from the past on how the value of this investment varies, and are not an exact indicator. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest USD 10,000.00. The figures are estimates and may change in the future.

The costs shown in the table above represent how much the expected costs of the product would affect your return, assuming the product performs in line with the moderate performance scenario. Disregarding the impact on your return in that scenario, the estimated entry and exit costs as a percentage of the face value are estimated to be 11.17% if you cash in after year 1, 9.68% if you cash in after 2 years and 8.68% if you cash in after the recommended holding period.

The table shows the impact on return per year.

The costs shown in the table above represent the split of the reduction in yield shown in the costs over time table at the end of the recommended holding period. The split of the actual estimated costs of the product is estimated to be as follows: entry costs: 8.68% and exit costs: 0.00%.

How long should I hold it and can I take money out early?

Recommended holding period: 4 years

The recommended holding period for the product is 4 years as the product is designed to be held until maturity; however the product may terminate early due to an autocall or an extraordinary event. You have no contractual right to terminate the product prior to maturity.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product back to the manufacturer.
