Type

This product is a secured debt instrument governed by English law.

Term

This product has a maturity of 29/10/2029 but can be redeemed earlier according to the conditions indicated in the "objectives" section below.

Objectives

This product is designed to provide a fixed coupon upon redemption. It is possible for the product to be automatically redeemed early based on pre-defined conditions. If the product is not redeemed early, the capital redemption amount is linked to the performance of the underlyings. Your capital will be fully at risk when investing in this product.

The Reference Underlying is the Underlying with the lowest observed level on the relevant observation.

For each individual Underlying, a Trigger Event occurs if the Underlying has been observed at or above the Early Redemption Barrier applicable on any day during the Early Redemption Observation Period (or at or above the Final Barrier on the Final Observation Date).

Coupon

Provided that the product has not been previously redeemed early:

On the Coupon Payment Date, you will receive the Coupon.

Automatic Early Redemption

During the Early Redemption Observation Period, if a Trigger Event has occurred on each Underlying since the product's inception (not necessarily at the same time), the product will be redeemed early and you will receive:

100% of the Nominal Value plus the Early Redemption Coupon.

Final Redemption

On the Maturity Date, provided that the product has not been redeemed early, you will receive a final redemption amount.

- If a Trigger Event has occurred on each Underlying since the product's inception (not necessarily at the same time) you will receive:

100% of the Nominal Value.

If a Trigger Event has not occurred on each Underlying since the product's inception (not necessarily at the same time) and the Final Level of the Reference Underlying is at or above the Capital Barrier, you will receive:

100% of the Nominal Value.

- Otherwise, you will receive the Final Level of the Reference Underlying multiplied by the Nominal Value. In this scenario, you will suffer a partial or total loss of your invested amount.

Additional Information

- The level of each Underlying corresponds to its value expressed as a percentage of its Initial Value.

- The Initial Value of each Underlying is its value observed on the Initial Observation Date.

- The Final Level is the level of the Reference Underlying observed on the Final Observation Date.

- Coupons are expressed as a percentage of the Nominal Value.

- Extraordinary events may lead to changes to the product's terms or the early termination of the product and could result in losses on your investment.

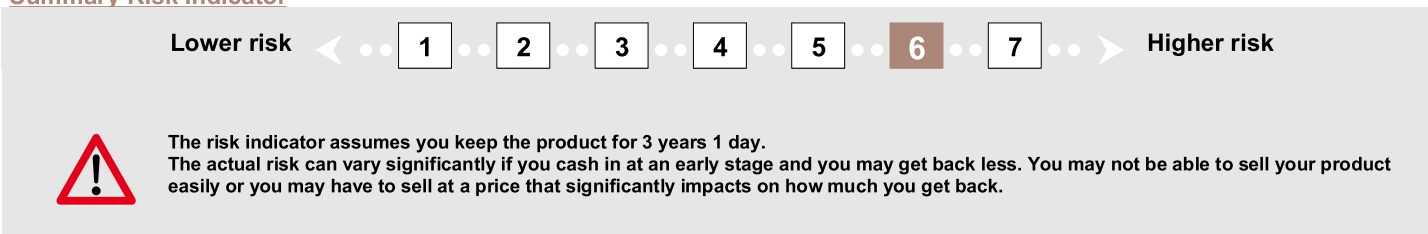
Intended Retail Investor

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Summary Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 6 out of 7, which is the second-highest risk class.

This rates the potential losses from future performance at a high level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

WHAT ARE THE COSTS?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended Holding Period: 3 years 1 day, which corresponds to the product maturity.

Under normal market conditions, Société Générale or an entity of its group ensures a daily secondary market during the life of the product by providing bid and offer prices expressed as percentages of the Nominal Value and the difference between the bid and offer prices (the spread) will not be more than 1.00% of the Nominal Value. If you want to sell the product before the Maturity Date, the price of the product will depend on market parameters at the time you wish to sell and you may sustain a partial or total capital loss. In unusual market condition, the resale of the product may be temporarily or permanently suspended.
